


### What is the ESSER III Grant?

The Coronavirus Aid, Relief, and Economic Security (CARES) Act

Provides funding to a Local Education Authority (LEA) through Section 18003 of the Elementary and Secondary School Emergency Relief (ESSER) Fund, to address the impact of COVID-19 on elementary and secondary schools.





### LEAs can use funds for the following activities:

Coordination of preparedness and response efforts of the LEA with State, local, tribal and territorial public health departments, and other relevant agencies to improve responses to prevent, prepare for, and respond to coronavirus

Provide principals and school leaders with resources to address the needs of the school

Activities to address the unique needs of low-income students, children with disabilities, ELs, racial and ethnic minorities, homeless students, foster care youth (including outreach and service delivery)

Develop and implement procedures and systems to improve the preparedness and response efforts of LEA.

Training and PD for staff on sanitation and minimizing the spread of infectious diseases

Purchasing supplies to sanitize and clean the facilities

Planning for and coordinating long-term closures, including providing meals, technology for online learning to all students, carrying out requirements under IDEA, and ensuring other educational services can continue



### LEAs can use funds for the following activities:

Purchasing of educational technology (hardware, software, connectivity) that aids in regular and substantive educational interaction between students and classroom instructors including low-income students and students with disabilities


Providing mental health services and supports

Planning and implementing summer learning and supplemental afterschool programs (addressing needs of low-income students, students with disabilities, ELs, Migrants, Homeless students and Foster Care students)

Other activities necessary to maintain the operation of and continuity of services and continuing to employ existing staff




ESSER III Requires consultation with all stakeholders





## Hamilton Timeline For ESSER III Application

- December 3, 2021: Hamilton Community Schools (HCS) Applied for ESSER III Grant
- December 8, 2021: HCS Released ESSER III
  Survey to all stakeholders
- December 17, 2021 January 4, 2022 Survey
  Results Compiled and Presentation Built
- January 10, 2022 HCS presents findings and "Use of Funds" ideas to community with Public Comment
- By March 1, 2022 HCS will amend original application to take into account stakeholder consultation




Provide Social emotional learning opportunities such as counseling, mental health and wellness resources for students, staff and families

- Families are healthier and stronger.






# Add instructional support for Intervention or Special Education

### Devices


 Ensure aging devices are taken offline and replaced with newer devices

- Ensure all students working from home have access to internet

### Diagnostic Testing / Online MTSS lessons

 Continue to purchase diagnostic reading and math assessments / as well as online MTSS lessons at all levels

### Math Summer School


K-6th Grade: Three weeks. Transportation and meals provided.

### Reading Summer School

• K-6th Grade: Three weeks. Transportation and meals provided.

### Credit Recovery

- 8th 12th grade: Six Weeks. Free of charge. Transportation and meals provided.
- 9th 12th: After School. Free of charge.

### Maintain District Facilities and Cleaning Supply Levels

- Purchasing supplies to sanitize and clean the LEA's facilities
- Repairing and improving school facilities to reduce risk of virus transmission and exposure to environmental health hazards
